

Waiver of Liability and Release of Claims

In consideration of participating in an intuitive reading with Asher Hartman, I acknowledge and agree to, on my own behalf, and on behalf of my personal representatives, heirs, assigns, executors, administrators, and next of kin, as follows:

- 1. I am at least 18 years of age, I have not been declared mentally incompetent, and I have voluntarily decided to participate in an intuitive reading;
- 2. I have requested an intuitive by Asher Hartman through my own free will, I am voluntarily participating in the reading, and I am accepting complete responsibility for my own medical, health, mental, emotional, psychological, spiritual and bodily well being;
- 3. I understand that any psychic reading or spiritual counseling is not and cannot be used as a substitute for any type of medical, health, psychological, psychiatric, or professional counseling, therapy, or treatment;
- 4. I understand the psychic reading in which I am participating is purely for entertainment, and that Asher Hartman does not claim 100 percent accuracy nor is accuracy in predicting the future the purpose of the reading;
- 5. I understand that no clairvoyant, psychic, medium, etc., can predict the nature, type, content and substance of any information that may be received during an intuitive reading;
- 6. I understand that any information received during an intuitive reading may be unpleasant, may evoke painful memories and may be emotionally difficult for me to receive;
- 7. I understand I and Asher Hartman will keep the reading I receive completely confidential. Neither party will promote or publish any part of the reading without permission;
- 8. I understand that I will make clear to Asher Hartman whether I am recording a reading on a device, on FaceTime, Skype or other mode of communication. I agree not to record a reading without permission;
- 9. I do on behalf of myself, my assigns, executors, guardians and all other legal representatives, hereby release, discharge, waive and forever relinquish Asher Hartman, their agents, employees, officers, directors, employers and any other person associated with the aforementioned persons and entities, from any and all known or unknown claims resulting from, arising out of or in any way connected with information I may or may not

receive during my voluntary participation in a reading with Asher Hartman and further agree that under no circumstance(s) will I, or any other person associated with me as a result of my reading, attempt to present any claims against, prosecute, sue, seek to attach any lien for any purpose including satisfaction of a judgment or other judicial decree, to the property of Asher Hartman and their heirs and I hereby waive all claims, demands, compensation and all actions that I or anyone associated with me or any other participant in the reading currently or hereafter may have for any injuries or perceived injuries or perceived or real losses I may suffer or believe to suffer because of or during my participation or involvement in a reading resulting from any actions, statements, answers to questions or omissions made by Asher Hartman or any person associated with Asher Hartman;

I understand and agree that in the event I bring any claim for damages against Asher Hartman or any person associated with Asher Hartman as a result of my actions, omissions, or other act, that I and/or my estate shall indemnify and hold harmless Asher Hartman and all persons associated with Asher Hartman from any and all claims, actions or damages, legal and otherwise made by me or anyone associated with me including the cost and expense, including reasonable attorneys fees, associated with defending such actions or claims;
- 11. I agree that in the event I engage in any activity or make any decisions based on the information provided by Asher Hartman, I do so at my own risk;
- 12. I release Asher Hartman from liability from any injury I may have received traveling to and from Asher Hartman's place of business.

I have carefully read this agreement and fully understand its content. I am aware that this is a waiver and release of potential liability and a contract between the above noted party and myself. I understand that this contract is binding and acknowledge that I am signing this of my own free will.
